- It is seen from the said information that a credit of Rs. 32,00,000/- has been recorded in your books of account during the previous year ended 31st March, 2024, stated to have been received from Tamrasetu Tradecraft Private Limited - Synthetic Demonstration Entity. The nature and source of the said credit has not been established on the material presently available on record.
- You are hereby required to show cause, on or before 21/01/2026, as to why a notice under section 148 of the Act should not be issued in your case for the assessment year 2024-25 in respect of the aforesaid amount.
- Your reply, along with such documentary evidence as you may wish to rely upon, may be furnished electronically through your registered account on the e-filing portal at www.incometax.gov.in under the 'e-Proceedings' tab. Replies furnished through any other mode may not be taken on record.
- If no reply is received by the date specified above, the matter will be decided on the basis of the material available on record and an order under section 148A(3) of the Act will be passed accordingly.
