- Now, therefore, you are hereby required to furnish a return of your income for the assessment year 2024-25 within the period specified in this notice, namely on or before 20/05/2026, in the prescribed form and verified in the prescribed manner, setting forth such other particulars as may be prescribed.
- The return of income is to be furnished electronically through your registered account on the e-filing portal at www.incometax.gov.in. This notice is issued in accordance with the provisions of section 151A of the Act and the scheme notified thereunder.
- This notice is being issued after obtaining the prior approval of the specified authority under section 151 of the Act, namely the Additional Commissioner of Income-tax, Range 1, Demo Nagar, vide approval reference DEMO/APPROVAL/151/2026/017 dated 19/02/2026.
- Your attention is invited to the provisions of section 276CC of the Act, which provides for prosecution in the event of a wilful failure to furnish a return of income in due time in pursuance of a notice under section 148 of the Act.
